- ServiceLink, our affiliates, or others you have transacted with;
- Consumer reporting agencies and/or governmental entities, either directly from these entities or through others.

This Personal Information is collected for the following business purposes:

Personal Information of minors:

ServiceLink does not knowingly collect the Personal Information of minors.

Sensitive Personal Information:

Consumers have the right to limit the use or disclosure of their "Sensitive Personal Information" to just actions necessary to perform specific purposes listed in the CCPA, as amended. Sensitive Personal Information includes government identifiers (social security, driver's license number or state ID, and passport number), precise geolocation, racial or ethnic origin, and other categories defined in California law.
